THIS DOCUMENT SERVES AS A LEGAL AND BINDING AGREEMENT BETWEEN THE GERMANTOWN BASEBALL LEAGUE, INC. (THE "GBL") AND THE PARENTS AND/OR GUARDIANS OF THE ABOVE-NAMED CHILD SUBJECT TO THE CONDITIONS SET FORTH BELOW: By signing below, I, as a parent (or guardian) of the above named child, who intends on participating in the GBL Baseball Program (the "Program"), hereby consent and give the express approval of all the child's parents and/or guardians, to the child's participation in any and all of the activities of the Program during the season indicated above. I hereby represent and warrant that I have such authority to consent to and approve the child's participation. I, along with the other parents and/or guardians (hereinafter referred to, collectively and individually, as "we"), accept and assume all risks resulting from, arising out of and relating and incidental to the conduct of all Program activities and transportation to and from such Program activities. We, jointly and severally, do further hereby forever release, forgive, discharge and cancel, and agree to indemnify and hold harmless, the GBL, the Program and each of their respective directors, officers, employees, coaches, organizers, sponsors, supervisors, agents and representatives, and all and each of them, from any and all actions, claims, liabilities, judgments, expenses, costs and losses of every kind and nature (including reasonable attorneys' fees) directly arising out of or resulting from, or reasonably related to, the activities of the GBL and/or the Program. In case of injury to the child named above, we hereby fully and unconditionally waive any and all claims against the GBL, the Program and each of their respective directors, officers, employees, coaches, organizers, sponsors, supervisors, agents and representatives. I will furnish a certified birth certificate for the above-named child and understand that all players in the Program must provide a birth certificate prior to any participation in the Program's activities. I understand that if the child named above is selected to a team, we will be responsible for significant other costs (registration fees, uniforms, tournaments entry fees, etc.). As signified by the mark of the undersigned parent or guardian of the above-named child, we hereby give consent for all medical care prescribed by a duly licensed medical doctor, for the above-named player, under and for whatever conditions are necessary, in the opinion of the said doctor, to preserve, the life, limb, or well-being of the child, as a consequence of participation in the GBL's and/or Program's activities. We authorize the directors, officers, employees, coaches, organizers, sponsors, supervisors, agents and representatives of the GBL to transport the above-named child as required or needed to and from any GBL activity. We understand that any insurance coverage that may or may not be part of the above-named child's registration fee for participating in the GBL and the Program is strictly SUPPLEMENTAL to our own coverage. We hereby also pledge, agree and covenant to abide and be bound by, and faithfully adhere to, the constitution, rules, policy statements, bylaws and guidelines (and any amendments thereto) of the GBL and/or the Program, including any and all decisions or resolutions of any administrative, organizational, or executive board of the GBL. Specifically, I have read the GBL issue management policy and the parents' code of ethics and conduct available for download at the germantownbaseballleague.org Web site. Upon reading these policies, I do understand them, and I covenant and agree to abide by them.
